Information on how to enter forms part of the terms and conditions of entry. Entry into the promotion is deemed acceptance of these terms and conditions. Headings in this document are included for ease of reference, and do not affect interpretation in any way.

1) The promoter is Jetstar Airways Pty Ltd (ABN: 33 069 720 243) of 79 Victoria Parade, Collingwood, VIC 3066 (telephone number 03 9200 7392) (**Promoter**).

Duration

2) All references to time in this document are a reference to the local time in Melbourne, Victoria, Australia on the date stated. The promotion commences at 9:00am (AEDT) on Wednesday 4 October 2017 and closes at 23:59pm (AEDT) on Friday 15 December 2017 (Promotion Period).

Eligibility to enter

3) Entry is open only to Australian residents aged 18 years or older (Eligible Entrants), excluding directors, management, employees and their immediate families of the Promoter and its related bodies corporate and registered travel companions of employees of the Promoter and its related bodies corporate.

Entry into the promotion

- 4) To enter, Eligible Entrants must during the Promotion Period book an Airbnb through the link at www.jetstar.com/au/en/airbnb, and then visit www.jetstar.com/au/en/airbnb, locate the promotion entry form, complete all requested details including, but not limited to, full name, email address, phone number and an answer to the question "Tell us in 50 words or less how you'd use the Jetstar & Airbnb prize pack if you won?", and submit the completed form.
- 5) The Promoter is not responsible for any lost, late or misdirected entries.
- 6) Eligible Entrants will receive one entry per booking, irrespective of the number of guests on the booking. Multiple entries are permitted if accompanied by multiple bookings. Each entry must be submitted separately and in accordance with entry requirements.

Any winners determined in accordance with clause 18 will be notified by email and by phone by 10:00am (AEDT) Monday 8 January 2018.

Limitation of liability and variation of terms

19) If any act, omission, event or circumstance occurs which is beyond the reasonable control of the Promoter and which prevents the Promoter from complying with these terms and conditions, the Promoter will not be liable for any failure to perform or delay in performing its obligations. The Promoter reserves the right (subject to any applicable law) to cancel, terminate or modify or suspend this promotion.

- 20) The Promoter, the provider of prizes (including any entity within the Airbnb group of companies), their related bodies corporate and their respective officers, employees, contractors and agents (**Promotion Parties**) will not be liable for any losses, damages, expenses, costs or personal injuries arising out of this promotion, the promotion of this promotion or the use of any prize, including but not limited to any breach of these terms and conditions, contract or tort (including negligence) and any other common law, equitable or statutory remedy (**Damages**) whatsoever, including but not limited to direct, indirect and consequential Damages, including Damages that cannot reasonably be considered to arise naturally and in the ordinary course of things, even if those Damages were in the contemplation of the Promotion Parties.
